- Enclose a check for \$250 made payable to Hamden Fish and Game.
- Attach a copy of Pistol Permit OR submit the two Background Checks described above. - Attach a copy of NRA Membership Card.
- A check for \$630.00 will be due at time of induction into the club.
- Applicants are on probation for the remainder of their first calendar year and for the next year thereafter. Members must perform 12 hours worktime per year or pay \$27.50 per hour for worktime that is not performed in any calendar year.
